This is an application for addition of party as Principal Defendant
No. 6(A) in the instant Admiralty Suit.

Mr. Md. Raihan Kawsar, learned Advocate appearing on behalf of
the applicant, submits that by an order dated 01.07.2026, this Court was
pleased to allow the application dated 30.06.2026 and release the
defendant vessel upon acceptance of a Bank Guarantee furnished by One
Bank PLC on behalf of Oceantra Ship Supply & Trading International.

He further submits that, as the said entity furnished the Bank
Guarantee for securing the release of the vessel, it has acquired a direct
and substantial interest in the subject matter of the suit and is, therefore,
a necessary and proper party to the proceedings. He contends that
without impleading Oceantra Ship Supply & Trading International as a
principal defendant, the dispute cannot be effectively and completely
adjudicated.

Accordingly, he prays that Oceantra Ship Supply & Trading International be added as a principal defendant to the suit to enable this Court to effectually and completely determine all the questions involved in the proceedings.

The application is not opposed.

In that view of the matter, I find substance in the application for addition of party and accordingly, the same is allowed. Let "Oceantra Ship Supply & Trading International of Mouri Corner (3rd Floor), Road-06, House-02, Block-G, Boropole Moor, PC Road, Chattogram, Bangladesh" be added as principal defendant No.6(A) in the instant Admiralty Suit.

The office is directed to make necessary corrections accordingly.

Let this order be served upon the principal defendant No. 6(A) by the usual course as well as with acknowledgment due registered post at cost of the petitioner. Requisites to be put in within 72 hours.
